Rules & Regulations

EXORA RUN 2019 – VIRTUAL RUN

1. Participants are only entitled to receive a Finisher Tee and a Finisher Medal.
2. Participants can expect delivery of the finisher tee & medal after 21st January 2019 and tracking number will be given in your email.
3. Delivery fee will be borne by organizer.
4. Bulk delivery is not applicable for all Virtual Run, whether individual or group registrations. All Virtual Run packages will be delivered individually.
5. Exora Run 2019 ['Event'] is a virtual run organized by IXORA Events and Management Sdn.Bhd. ['the Organizer'] and is open to anyone aged 13 and above; each participant attends the session at his/her free will.
6. This Event will be held from 1st Jan 2019 to 21st Jan 2019. The Organizer reserves the right to postpone or cancel the Event at any time.
7. Participants must be certified fit to participate in this Event. The Organizer shall not be liable for any accident or mishap which arises as a result of non-disclosure of medical conditions by the Participants.
8. Participant agrees to provide true, accurate, current and complete information about the Participant. The Organizer may contact the Participant from time to time by email. Any notice sent to the email address registered with the Organizer shall be deemed as received by the Participant.
